1. THE GROUP OF TAYLOR OPERATIONS (**6P**): Consider the Taylor operator $T[a] := \exp\left[a \frac{d}{dx}\right]$ which generates one-dimensional displacements: $T[a]f(x) = f(x + a)$.
 - a) (**2P**) Derive the group manifold, its dimension, and show whether it is compact.
 - b) (**2P**) Find the matrix which describes how T acts on a vector made of the n functions $\{x^{n-1}, x^{n-2}, \dots, x^2, x, 1\}$, with $n \in \mathbb{N}_0$.
 - c) (**1P**) What is the dimension of this representation?
 - d) (**1P**) Is this representation unitary?

2. COUNTING MATRICES (**4P**): This is some clean-up work.
 - a) (**2P**) Show $\det M = \exp \operatorname{tr} \ln M$ when M is diagonalisable.
 - b) (**2P**) Determine the real dimension of the Lie algebra of the group $U(N)$ by counting the number of independent entries in an anti-Hermitian matrix. You may *not* use that $\dim G = \dim L[G]$.

3. STRUCTURE CONSTANTS AS LIE ALGEBRA (**6P**): There are *four* criteria which define a Lie algebra: closure, bi-linearity, anti-symmetry, Jacobi-identity. We now interpret the structure constants f^{abc} as matrices $(t^c)^a_b = (if^c)^a_b$ which give the (ab) entry of the c th generator of the Lie algebra. That means the (ij) entry of the commutator reads a bit weird at first sight, but you will manage (remember you can call a summed index whatever you want):

$$([t^a, t^b])^i_j = (if^{ab}_c t^c)^i_j \implies (if^a)^i_k (if^b)^k_j - (if^b)^i_k (if^a)^k_j = if^{ab}_c (if^c)^i_j .$$

- a) (**4P**) Show that these matrices obey the definition of a Lie algebra.

Point of Information: This representation is called the ADJOINT REPRESENTATION of the Lie algebra. It always exists as matrix representation because you just constructed it.

- b) (**2P**) Show that the generators of the adjoint representation of $L[SU(2)]$ are the angular momentum operators L_i which generate $L[SO(3)]$.

4. BASIS OR NO BASIS? (5P) Consider the Lie algebra of strictly upper-triangular matrices (i.e. all diagonal entries are zero as well). Find a possible set of generators and discuss whether they form a complete, ortho-normalisable basis.

Modification: If you have problems with the general case, you may specialise to the case of upper-triangular 3×3 matrices – but then you get at most 3P.

5. PROPERTIES OF $SU(2)$ AND ITS LIE ALGEBRA (9P):

- a) (2P) Show that every element of $SU(2)$ can be written as $\begin{pmatrix} a & b \\ -b^* & a^* \end{pmatrix}$, where a, b are complex numbers and $|a|^2 + |b|^2 = 1$. Therefore, the group-manifold of $SU(2)$ is S^3 , i.e. the three-dimensional surface of a sphere in \mathbb{R}^4 .

- b) (2P) Prove the identity

$$\exp[i\alpha_a \frac{\sigma^a}{2}] = 1 \cos \frac{\alpha}{2} + i \frac{\alpha_a \sigma^a}{\alpha} \sin \frac{\alpha}{2} ,$$

where $\alpha = \sqrt{\alpha^a \alpha_a}$ is the length of the vector α^a in the space spanned by the Pauli matrices σ^a .

Hint: The properties of the Pauli matrices come in quite handy, as does the definition of the function of a matrix by its corresponding Taylor expansion.

- c) (3P) Show that the mapping of its Lie algebra on the Lie group $SU(2)$ is bijective (one-to-one and onto) for $\alpha \in [0; 4\pi[$ (i.e. 4π is *not* in the bijective region). It may help to interpret $\{1, \sigma^a\}$ as the orthogonal basis vectors of 4-dimensional space, in which $SU(2) \simeq S^3$ is a sphere.
- d) (2P) Argue whether the manifold of $SU(2)$ is curved or not, i.e. if the only place at which the coordinate axes $\{\sigma^a/2\}$ of the Lie algebra intersect is the origin.

Consequence: You have just proven by practical construction: (i) The tangent space of $SU(2)$ in the identity suffices to construct all of $SU(2)$; (ii) $SU(2)$ is connected; (iii) as is S^3 ; (iv) both are compact.
