

MEMORANDUM TO JUSTICES BLACKMUN, STEVENS
O'CONNOR, KENNEDY AND THOMAS

Attached for your information is a rather lucid summary of the election pool in which each of us participated. As you will note from the last page, left hand column, Sandra proved to be positively prescient, while four of us proved to be considerably less so. The net result is that Sandra has won \$18.30, Harry has won \$1.70, John and I have lost \$6.30, Tony has lost \$2.30, and Clarence has lost \$5.10. I shall pay Harry \$1.70, and Sandra \$4.60. John, Tony, and Clarence should pay the full amount of their losses to Sandra.
